



## FOSTER CARE AGREEMENT

The Foster Family agrees to foster the following animal (hereinafter called, "Rescue Dog") from Gulfstream Guardian Angels Rottweiler Rescue (hereinafter called, GGARR).

### **As a Foster Family, I/We agree to the following:**

1. I/We understand the Rescue Dog is currently named \_\_\_\_\_, and it is necessary for record keeping, appointments, public information, etc. to refer to the Rescue Dog by this name.
2. To allow a representative of GGARR to visit my premises to ensure the terms of this agreement have been kept.
3. The Rescue Dog will be provided with adequate fresh food and water. Under no circumstances shall the Rescue Dog be maintained outside as a yard dog and shall never be staked or chained outside. Foster Family will provide indoor shelter/indoor sleeping quarters, exercise, and veterinary care. The Rescue Dog will not be transported in an open pickup truck, convertible or to be left in a car when air temperatures exceed 65 degrees.
4. To provide a safe collar, to be worn at all times.
5. To obey all applicable laws governing control and custody of Rescue Dog.
6. To foster the Animal as a family companion only.
7. If fostering a dog, the Foster Family agrees to have a clean, secure fenced area for the Rescue Dog. If a fenced enclosure is not available, Foster Family agrees to leash walk dog.
8. Foster Family agrees to bring the animal to veterinary appointments and adoption events or allow GGARR to make arrangements, to make alternative transportation to the appropriate appointments/events.
9. Foster Family understands that GGARR retains legal control of the Rescue Dog and is not authorized to make any legal or medical decisions on his/her behalf.
10. Foster Family agrees to allow potential adopters that GGARR has approved to meet the Rescue Dog at the family's home OR at another reasonable location.

11. Foster Family agrees to respond to GGARR within 24 hours, concerning the Rescue Dog.
12. All medical expenses that are approved by GGARR and treated through GGARR's approved veterinary office will be covered by GGARR. **If you take our dog to your vet, it will not be covered.**
13. Foster agrees to release GGARR and its Members or Representatives of any and all possible claims, arising from injury or damage caused by the Rescue Dog to any person or property.
14. If you choose to adopt your foster dog, you will be required to fill out an adoption contract and pay the appropriate adoption fee.
15. As a foster family I/We agree to release the previous owner as well as GGARR and its Representatives of any liability, arising out of duties as a Foster Family, from this date forward.
16. I/We agree to abide by the foster conditions and I/We have read and fully understand that GGARR may repossess this Rescue Dog at any time if the foster conditions are violated or the animal is mistreated.

**BEHAVIORAL DISCLAIMER**

Although GGARR dogs are behavior tested and we work hard to ensure that our dogs are well adjusted and non-aggressive, we cannot guarantee the personality or behavior of any dog.

Foster acknowledges and agrees that by entering into this agreement, GGARR has not made any representations about the behavior or personality traits of Rescue Dog, and Foster is agreeing to waive, discharge, release and hold harmless GGARR, its members and Representatives, from any cause of action arising out of or relating to the behavior of the Rescue Dog, including any loss to persons or property caused by the acts of Rescue Dog or any liability to third parties that Foster may potentially face due to acts of Rescue Dog.
